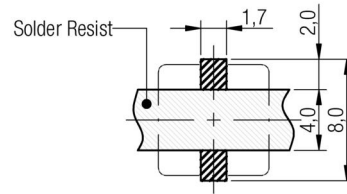


**A Dimensions: [mm]**

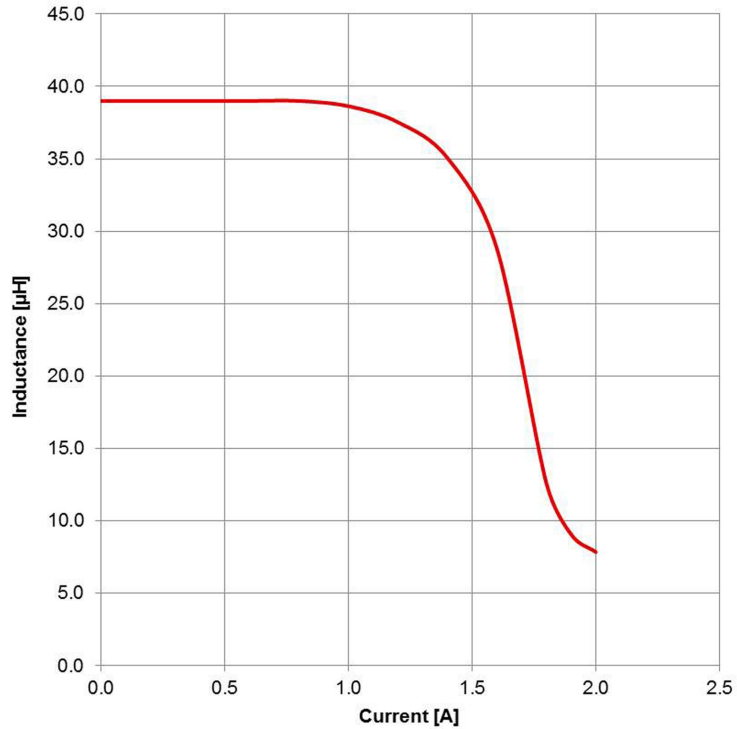

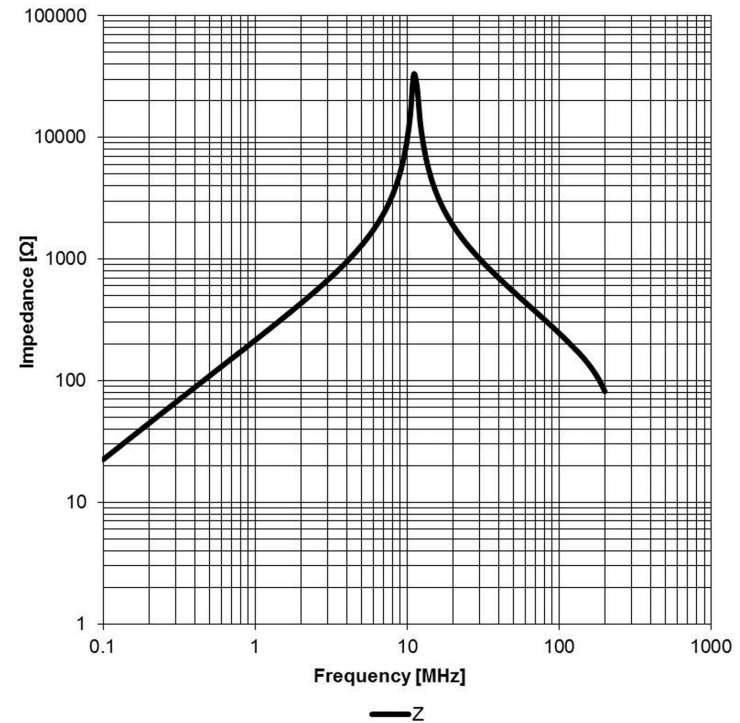



### Product specific:
